ON THE RADAR

Administration Health Workforce Initiatives Draw Mixed Reviews

If you work in the long-term care space you are familiar with the Biden Administration's efforts to strengthen the health care workforce. While these initiatives are the first meaningful proposals to emerge from Washington in years, they are being met with mixed reviews from providers who have been battle tested since well before the COVID-19 pandemic.

One proposed rule is expected to set the number of hours staff must work per resident in long-term care facilities. If this proposal is finalized, long-term care facilities would need to hire more staff, which has proven incredibly difficult in recent years. This is due, in part, to persistently low reimbursement rates and low pay for physically and emotionally taxing work. It is not clear what kind of flexibility will exist for providers or when the rules will take effect, but this is of great interest across the industry.

There is also, in a separate rule, a proposed 80-20 rule, which means that at least 80 percent of Medicaid payments for personal care, homemaker, and home health aide services must be spent on compensation for direct care workers. The other 20 percent would need to be spent on administrative overhead, but stakeholders are concerned that CMS underestimates what administrative overhead entails for these providers. These two initiatives could be finalized this fall and are being followed very closely by stakeholders and Congress.

To be clear, there are several organizations that strongly support these initiatives and believe they will improve quality and access to care. We all share a desire to see more action in this space that will meaningfully improve access to care while strengthening the infrastructure for providers and direct care workers to receive higher wages. Biden Administration to Establish Dementia Care Program

The Biden Administration announced plans for a new dementia care model titled, the Guiding an Improved Dementia Experience, or GUIDE. The model will help to address gaps in care for this population while strengthening access to support and resources for providers. With 6.5 million adults living with dementia, and the number expected to grow over the coming decades, CMS is building out the infrastructure to deliver care for this growing population with varying needs across the lifespan.

HHS Launches Long Covid Office

Last month, HHS announced a new office to lead government efforts to address and understand long Covid. The Office of Long Covid Research and Practice will coordinate across the government to scale up the federal government's response to Long Covid, closely aligned with the National Research Action Plan on Long Covid. The office will also support and operationalize the <u>Services and Supports for Longer-</u> <u>Term Impacts of COVID-19</u> report, which was published last year.

Long Covid and its connection to long-term services and supports is not yet understood, but the Biden Administration is signaling that this could be an area of need for this population.

CMS Allowing States to Continue COVID-era HCBS Waivers.

CMS recently announced that states can continue the HCBS Appendix K waivers past November 11, as long as they are added to the 1915(c) waiver programs. The HCBS Appendix K waivers allowed for states to expand where services were provided and allowed for payment flexibilities such as payment for family caregivers. CMS is looking for states to submit amendment proposals to CMS by November 11 for approval. CMS hopes that this extension will minimize any disruptions to beneficiaries, but there is some worry that states might not extend the HCBS waivers.

ISSUE OF THE WEEK: 700,000 Dropped from Medicaid in April

Across 18 states in April, more than 700,000 people lost Medicaid coverage. This is part of the national unwinding due to the end of the COVID-19 Public Health Emergency which is expected to see as many as 15 million people lose their health insurance.

Of the 2.2 million people who were subject to renewals in April, roughly one million people had their coverage renewed, 715,000 people lost coverage, and roughly 500,000 renewals were still pending. The troubling data from CMS points to 80 percent of those who lost coverage did so because the state was unable to determine whether those individuals were still eligible. KFF's data was even more troubling as their data from 38 states found that nearly 3.8 million beneficiaries lost coverage.

HHS is urging states to work closely with stakeholders to ensure a smooth transition to other coverage for those no longer eligible for Medicaid, but not all states are expected to implement such strategies. We continue to closely follow this space and encourage you to reach out with questions.

In 2021, Texas and Virginia received grants to help increase and enhance collaborations across systems to create a seamless experience for youth with intellectual and developmental disabilities (I/DD) as they transition between school and work in the community. The Virginia and Texas grantees used their funding to focus on youth with I/DD in racially minoritized communities and limited English-speaking households. This webinar will go over what evaluation strategies these grantees used and how they can be applied to other programs.
